Understanding Animal Welfare

- Definition: Animal welfare refers to the well-being of animals, encompassing their physical and mental health.
- Five needs:
 - **Suitable environment**: The animal should have a suitable environment.
 - Suitable diet: The animal should have a suitable diet.
 - Normal behaviour: The animal should be able to exhibit normal behavior patterns.
 - **Housing**: The animal should be housed with, or apart from, other animals.
 - Protection: The animal should be protected from pain, suffering, injury, and disease

Key Responsibilities

- 1. Daily Monitoring:
- Conduct daily checks on all animals.
- Observe behaviour, appetite, and physical condition.

2. Health Assessments:

- Perform regular health assessments, including weight checks and body condition scoring.
- Identify signs of illness or distress.

3. Record Keeping:

- Maintain accurate and up-to-date records of each animal.
- Document health assessments, treatments, and behavioural observations.

4. Feeding and Nutrition:

- Ensure all animals receive a balanced diet appropriate to their species.
- Monitor food intake and adjust as necessary.

5. Environmental Enrichment:

- Provide enrichment activities to encourage natural behaviours.
- Regularly change and rotate enrichment items to maintain interest.

6. Veterinary Care:

- Coordinate regular veterinary check-ups and vaccinations.
- Be familiar with common health issues for each species.

Emergency Protocols

- Recognizing Emergencies:
- Be aware of signs that require immediate veterinary attention.
- Emergency Contacts:
- Keep a list of emergency contacts, including veterinary services and animal control.
- Reporting Procedures:
- Report any concerns or incidents to the designated supervisor promptly.

Standard Operating Procedure (SOP) for Monitoring and Ensuring the Health and Welfare of Animals

Purpose

Behavioural Enrichment

- Toys and enrichment tools
- Social interactions with other animals
- Regular exercise and playtime

Nutrition

- Ensure that all animals receive a balanced diet appropriate for their species and age.
- Monitor food intake and adjust diets as necessary.

Regular Veterinary Care

- Schedule routine health checks with veterinary staff.
- Administer vaccinations and parasite control as recommended.

Emergency Procedures

- In case of a health emergency:
- Isolate the affected animal to prevent the spread of illness.
- Notify veterinary staff immediately.
- Document the incident and any actions taken.

Training

- All staff members must undergo training on animal welfare practices and monitoring protocols.
